New TEFAP Agreement:

Every partner agency is required to sign the new TEFAP agreement and return it to the Agency Relations team by **December 1**st. This agreement is available **HERE**, in the Resource Center, in the CAFB warehouse, and will be emailed to you shortly.

Voter Registration Outreach:

As part of our advocacy outreach, we are encouraging our clients, volunteers, partners, and employees to register to vote. This is a nonpartisan effort, and does not involve endorsement of any candidate or proposal.

If you would like to have voter registration cards at your agency, we'd be happy to send you a packet. These cards are self-addressed, postage-paid applications that a person can fill out and drop in the mail. They will go directly to the Secretary of State's office. A voter registration card will then be mailed back to the applicant.
