# **Policy Update**

#### **TEFAP Temporary Intake Form**

The TDA waiver to remove the required signatures from participants/proxies on TEFAP intake forms has been extended through May 31, 2020. Agencies must still obtain federally required intake criteria to properly determine and document eligibility. Please see the revised temporary intake form linked on the Agency section of our website <a href="here.">here.</a>

Please ensure to determine eligibility based on categorical and/or income first. If the participant does not qualify from those two, please utilize the household crisis option and document the reason: lost job, furloughed/laid off, etc. If you have any questions regarding the intake process or TEFAP eligibility, please reach out to your relationship manager.

# **Reminder: PPE and Social Distancing Guidelines**

As some businesses start to re-open, we would like to remind the network that CTFB continues to recommend that your agency staff and volunteers follow the CDC guidelines for practicing social distancing and using PPE such as masks & gloves. Please continue to use alternative distribution models outlined in our "Guidance for Alternative Distribution Models" tool online.

Agencies will still be required to wear facial coverings at the time they pick-up orders from the CTFB warehouse or on regional deliveries, no exceptions.

As you know, items move quickly on our shopping list. If you do not see Emergency Food Boxes on the shopping list when you're placing your order, please contact the AR Hotline *before* you place your order. We are working with our Food Sourcing Team to update the inventory and make them available for agencies to order as quickly as possible.

Please take into consideration that one pallet holds 42 Emergency Food Boxes. Come prepared to pick up the number of boxes on your order. If you order more than the 84 box limit, it's possible your order will be cut based on truck capacity.
